## **PIER 2 NOTICE OF NEW TARIFF AND DWELL TIME FOR OUT OF GAUGE (OOG) CONTAINERS**

Dear Peter

The meeting on 21 April 2023 and 05 May 2023 refers.

We appreciate the positive collaboration and input received for SAASOA members and have incorporated the input to determine the below process, new tariffs, change in import storage days and dwell time for OOG units. These will be effective from 01 September 2023.

### **1. Import Containers**

- The total number of OOG containers must be declared on the daily ETA document.
- The confirmed number of OOG containers and the evacuation plan will be discussed and confirmed at the Pre-plan meetings that are scheduled by TPT Planning Teams.
- Storage days for OOG will change from 3.25 days to 24 hours from the date of discharge.
- The tariff will be applicable from 00h01 on day 2 at a cost of R6693 (per container, per day or part thereof).

### **2. Transshipment Containers**

- Storage days will remain as 7 days as per the TPT Tariff book.
- The storage tariff will be applicable from
  - day 8-10 at a cost of R4106,
  - day 11-14 at a cost of R6693, and

### **3. Export Containers**

- The OOG container must be stacked on the last day of stack closing. The delivery time must be coordinated between Vessel Planner and TPT Planner.
- Storage charges on short shipment containers will be applied from the time the container entered the terminal up until it is removed from the terminal.
- The tariff will be applicable at a cost of R 4183 (per container, per day or part thereof).
